***GRAND BETHEL:***

Grand Bethel members present shall be entitled to one vote. No vote shall be cast by proxy.

***GGC:***

All members of the GGC (Executive members of the BGC and all PBGs and PABGs of this jurisdiction) are entitled to one vote each when present at the Annual Session. No member may have her/his vote cast by proxy except as follows (see Art. VII, Section 3 of the Constitution of the GGC):

- 1) A proxy shall be issued to an Associate member of the BGC only if the Associate member has Masonic status or affiliation for eligibility to become an Executive member of a BGC.
- 2) A proxy shall be limited to the particular Annual Session for which it is issued.
- 3) No person shall have a proxy for more than one office or be entitled to more than one vote.
